

CCIL All Sovereign Bonds Index (CASBI)

Introduction

The government securities market is considered as the backbone of fixed income securities market and is the prime funding avenue for the government. It serves as a benchmark for portfolio management, an indicator of market performance and development, and also forms the basis for derivative products like options and futures. CASBI index is designed to capture the performance of the bond market due to broad movement of rates across tenors. The index comprises 31 securities spread across all tenors.

BOND INCLUSION RULES

Data: At least one representative bond from each of the maturity years of the currently outstanding bonds

Issuer: Central Government

Price: Volume weighted average price (VWAP) or model price when there are no trades

Tenor: Minimum tenor is 1.5 years (Residual maturity on the index resetting date is considered)

Base Date: December 31, 2003

Base Value: 1000

Weighting: Market Capitalization

Rebalancing: Monthly

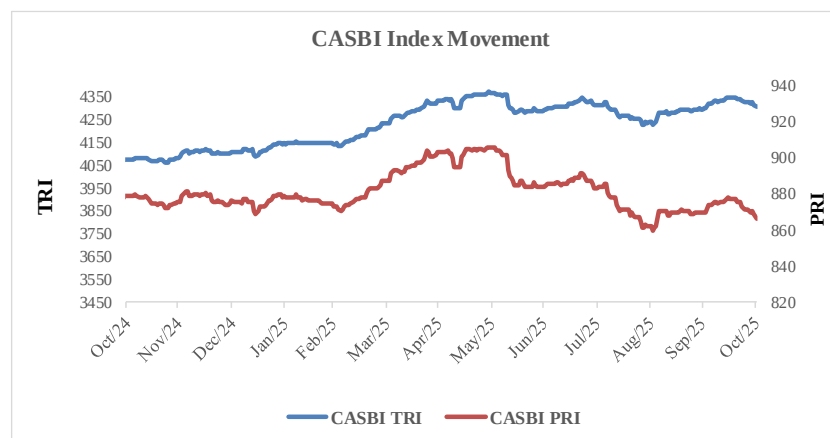

INDEX MOVEMENT



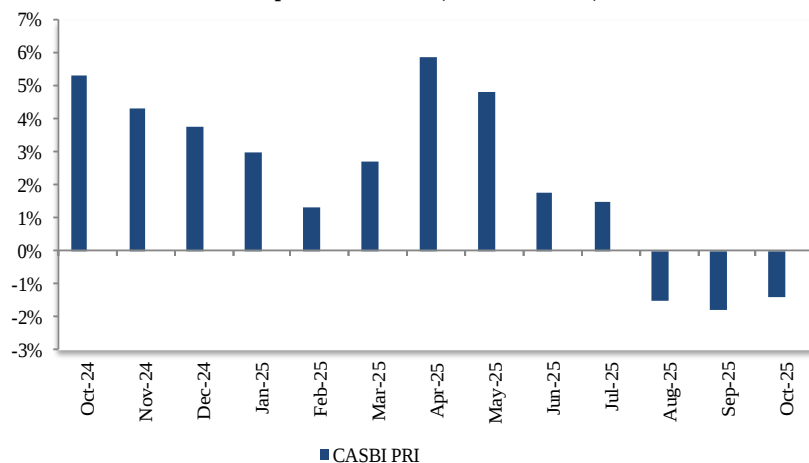

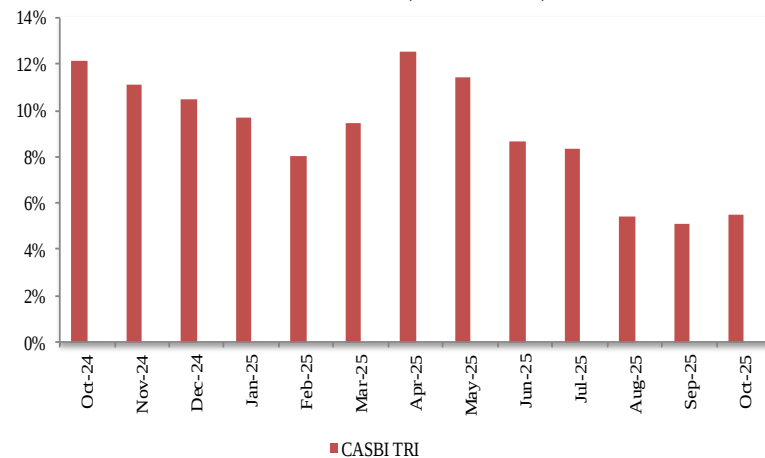
